According to Director Journal School Education Department Punjab and State Project Sarv Shiksha Abhiyan Letter No. 75444 dated: 06.11.2009 fire extinguishers should be kept in working condition in the school. Any untoward accident will be the responsibility of the concerned school.
6. In Case any additional Extension and Modification of this Building is to be caused out the same be carried out under the supervision of a technical qualified engineer and this certificate may again be obtained after completion from the undersigned.
7. In Case Building is affected by flood or there is any settlement of walls foundations or sagging of rooms etc. immediate inspection of undersigned be arranged to check the stability & Safety of the building.
8. In case of cracks and settlement in the building, the building should be vacated immediately.
9. If you make any changes in these conditions at your own level, the Department of Public Works will reserve the right to cancel the NOC issued to you without any notice.
